ADVERTISEMENT TERMS AND CONDITION

This order constitutes a binding contract between your organisation and the Ahlebait Network Ltd. You warrant that you have full authority to enter into this contract and shall be jointly and severally liable for payment and fulfilling the terms herein. All terms agreed between the parties shall be confidential.

2) This contract is not cancellable and in case of a cancellation, a full rate card price of £150 per spot will be charged as per spot for the spots consumed. There will be no program placement of spots unless defined by premium pricing. Premium for program placement is 50% over and above the base cost.

3) We need 5 working days to schedule spots. Unpaid spots / sponsorship could be withdrawn without notice or liability by Full price of contract payable.

4) The details set out in this order form together with the standard terms and conditions of the Ahlebait Network Ltd constitute all the terms. If you have not previously done business with the Ahlebait Network Ltd or are unsure as to the content of our standard terms and conditions please request a copy. If you have not asked for a copy of the standard terms and conditions, it shall be assumed you already have a copy and have accepted the said terms and conditions. The said terms and conditions shall be binding on you and shall supersede all oral and past written representation

5) You are solely responsible for submitting suitable ASA/ Ofcom and legally compliant advertising/sponsorship material by the due date. If you are in any doubt as to the format of the film, contact the airtime sales department immediately. If you fail to supply the advertising material by the due date you may still be responsible for paying the price shown above even if your advertisement does not appear due to loss of profit for slots booked. To ensure an entitled time band, we need your signed contract, advance payment (unless otherwise agreed in writing) and advertising material at least 5 working days prior to the commencement date of the activity/advertising.

6) Shall have the sole discretion of airing of any commercial less or more than 30 seconds in primetime.

7) This contract is valid only for the contractual period mentioned herein and the territory of UK and Europe. All entitlements expire if you fail to use them within the stipulated period. In such event of underutilisation of commitment, and/or in the event of failure to pay on time, this contract may be terminated and you will be invoiced for consumed spots in accordance with the standard rate card or will have to pay the full package price agreed under this contract, at the discretion of if there has been loss of sale or profit. Sponsorship tags will be cancelled and you will be billed for them should you fail to consume spots. Clause 2 & 6 of the general terms and conditions will deal with cancellation.

8) Payments should only be made by crossed cheques and no payment should be made in cash. Any claims that payment was made in cash shall not be accepted in settlement of dues.

9) All the Payments payable within 30 days credit period by crossed cheque payable to each bounced cheque will incur a £100.00 admin charge or by way of Bank transfer.

10) Ahlebait Network Ltd reserves the right to substitute a programme offered to a client after the start of the campaign with another programme with a similar time slot, on the same terms and conditions, in the event of the former programme ending or being replaced or discontinued prior to the end of the sponsorship campaign. The client agrees that Ahlebait Network Ltd shall not be held liable for any refunds or claims in this regard.

11) Any dispute over the invoices raised must be sent in writing to Ahlebait Network Ltd within 7 days of the invoice date and shall be dealt with if valid. Any oral or future claims shall not be entertained. Lack of expected response shall not be considered a valid dispute for non-payment.

12) The contract shall be governed in accordance with the Laws of England and you hereby agree to submit to exclusive jurisdiction of the English courts in England.

13) Ahlebait Network Ltd shall be entitled to conduct credit checks on all clients and agencies for the purpose of decisions on credit and debt recovery as well as add interest as claimable under law and charges of 20% plus VAT, late payment charges and legal costs for collection of late payments passed onto debt recovery agents.

IMPORTANT NOTE:

The contract is conditional upon the legal approval of your advertising commercial which is at the absolute discretion of. It may be withdrawn at any stage prior to transmission. While we will still utilise our best endeavours to ensure you are informed as soon as practicable, shall not be liable for any loss, including costs incurred in producing a commercial and any direct, indirect or consequential loss of profit or business tags and shall only refund to you/ proportionate advance payments made for unconsumed spots after billing as per rate card rate or as agreed with the sales person for consumed spots. This proposal is confidential and on any disclosure to agencies or third parties by the client.
